AWARE Early Head Start (EHS) is a year-round federally funded comprehensive child development program providing EHS services in our classrooms and within licensed partner child care agencies. The program focuses on early childhood development and education, parent involvement, age-appropriate screenings, disability services, family and social services, nutrition, social emotional development and mental health.

Parents and community members can help lead and make decisions about the EHS program. Policy Council members are elected by parents of children enrolled in the program.








# **OVERVIEW**








### COMPREHENSIVE SERVICES FOR CHILDREN & FAMILIES

Healthy children are ready to learn. EHS provides support for children and families needing health and dental services, referring children for treatment, assisting families with finding a medical home, and obtaining insurance coverage. Our health specialists provide health education and training for parents and staff, including hand washing and preventive oral health care.









# **Disability Services**


Ten percent of our enrollment is dedicated for children with diagnosed disabilities. In partnership with Part C providers, children receive services to address their disabilities. Each child receiving Part C services has an individualized family plan (IFSP), which includes individualized goals. Children and their families receive transition support as they age out of EHS services to ensure continued disability services remain in place, as indicated.

Children eat nutritious meals "family style," which promotes positive social interactions and self-help skills. All EHS classrooms and child care facilities participate in the Child and Adult Care Food Program (CACFP).

### Health Services Advisory Council

The statewide Health Services Advisory Committee (HSAC) meets twice a year to bring together staff, parents, healthcare providers, and other community health partners to discuss the planning and operations of AWARE Early Head Start's health services. The committee's mission is to support the health and wellness of each and every Early Head Start child and family.

## SERVICES DELIVERED TO FAMILIES

Family Advocates provide opportunities for families to identify their strengths, goals and services needed through a Family Partnership Agreement. They assist families with recognizing and achieving family engagement outcomes in seven areas: Family Well-Being, Positive Parent Child Relationships, Families as Life-Long Educators, Families as Learners, Family Engagement in Transitions, Family Connections to Peers, and Community Families as Advocates and Leaders. Family Advocates offer home visits, resource referral, parent education, and crisis assistance. They also assist families with health requirements, accessing Best Beginnings subsidy assistance and coordinating parent committee meetings.

# **Family Engagement**

AWARE Early Head Start provides so much more than education for young children. We believe the parent is the child's first and more important teacher. We also believe the whole family plays a vital role in a child's development and school readiness. Parent and family engagement are evident in all areas of our EHS program. Parents participate in activities aimed at building healthy families through a strength-based approach, including the following:


- Parent committee meetings to provide parent leadership opportunities and program input.
- EHS parent representation on Policy Council.
- Family partnership agreement, including identification of family goals
- Collaborative partnership with EHS staff.
- Individual parent-teacher conferences.
- Child find opportunities to ensure children are typically developing.
- Promoting resiliency through the Devereux Early Childhood Assessment.
- Transition planning with local school districts, Head Start, and Part C agencies to ensure child success beyond EHS.



Mental health of children and the adults who care for them is critical to children's school readiness. Licensed clinical mental health consultants are available on-site at the Early Head Start and Child Care Partner facilities. Consultants partner with caregivers to support healthy social and emotional development of children while increasing the capacity of adults to better understand the needs of infants and toddlers and the importance of early relationships

Each child receives a social-emotional screening using the Devereux Early Childhood Assessment - Infants/Toddlers tool. Clinicians provide support to EHS staff, families, and children to ensure positive social emotional growth.





### **SCHOOL READINESS**

Early Head Start defines school readiness as a child possessing the skills, knowledge, and attitudes necessary for success in school and later learning in life.


The goal of at least 80% meeting their age expectations in the following areas have been adopted by our Early Head Start program in collaboration with our school readiness team:




- Children are assessed three times per year using the My Teaching Strategies assessment, measuring growth on Widely Held Expectations by age
- Children's social-emotional growth is assessed three times per year using the Devereux Early Childhood Assessment
- Families complete the Ages and Stages Questionnaire screening at enrollment
- Child level data is collected and reviewed three times a year for planning and individual goal setting

# COMMUNITY NEEDS ASSESSMENT

A community-wide strategic planning and needs assessment was updated in January 2024 as required by Head Start Performance Standards to help with understanding community strengths and identifying programs in our services. The assessment in conjunction with other program date informs AWARE Early Head Start program planning.

**Rentals** The price of rentals increased in all the EHS communities.



**Child Care** Licensed child care facilities decreased in Gallatin and Yellowstone counties and increased in other EHS counties.



Housing Cost The median cost of houses increased in all the EHS communities.

# 2023-2024 Highlights



#### Enrollment

AWARE EHS received approval for an enrollment reduction in November 2023, reducing the total EHS slots from 212 to 151.

AWARE EHS is on a twelve month full enrollment initiative (FEI) with the Office of Head Start due to consecutive months of being under enrolled. The FEI is designed to assist programs with achieving full enrollment of funded amount. Following the completion of the FEI, AWARE EHS must maintain 97% enrollment for an additional twelve months.



#### Volunteers

Six foster grandparents are volunteering time in our EHS classrooms

Community volunteers assisting in the EHS classrooms and facilities.



#### **Professional Development**

EHS family advocates achieved Family Engagement certification after participating in a three day course and passing an associated exam.

AWARE EHS participated in training with the Head Start Regional Office utilizing Prevent, Teach and Reinforce for Young Children, a research proven approach to challenging behaviors.

EHS and child care partner staff obtained Quality of Care for Infants and Toddlers (QCIT) certification. The QCIT is a tool used to measure caregiver support for infant toddler social emotional, cognitive, language, and literacy development.



### **STARS TO QUALITY**


STARS to Quality program is a quality rating and improvement system through the State of Montana. STARS is currently in a redesign phase and is not accepting new applications until possibly October 2025. The STARS system is designed to strengthen programs with continuous improvement through guidance, strategies and incentives. EHS and Child Care Partners continue to utilize training and resources still offered through STARS.

# BUDGET

### **Financial Information and Audit Results**

#### **Federal Share**

Early Head Start funding comes from the Office of Head Start and is awarded after the grant application has been approved.

#### Non-Federal Share (In Kind)

Each Head Start program is required to match each dollar of federal funds with 20% non-federal share or in kind. AWARE EHS receives the majority of its in-kind from parent and community volunteers, parent-child activities, and community donations.

#### **Administrative Costs**

Early Head Start programs are required to track administrative expenses. The maximum allowable cost for administration is 15% of the total expenditures and in kind. In 2021-2022, administrative costs were 10.53% of the total.
